3: Hazards Identification

Potential Acute Health Effects: Hazardous in case of ingestion. Slightly hazardous in case of skin contact (irritant, permeator), of eye contact (irritant), of inhalation.

Potential Chronic Health Effects: Slightly hazardous in case of skin contact (sensitizer).

CARCINOGENIC EFFECTS: Not available.

DEVELOPMENTAL TOXICITY: Not available. The substance may be toxic to central nervous system (CNS). Repeated or prolonged exposure to the substance can produce target organs damage.

4: First Aid Measures

Eye Contact: Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open. Cold water may be used. Get medical attention.

Skin Contact: In case of contact, immediately flush skin with plenty of water. Cover the irritated skin with an emollient. Remove contaminated clothing and shoes. Cold water may be used. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention.

6: Accidental Release Measures

Small Spill:

Dilute with water and mop up or absorb with an inert dry material and place in an appropriate waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

Large Spill:

Absorb with an inert material and put the spilled material in an appropriate waste disposal. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system. Be careful that the product is not present at a concentration level above TLV. Check TLV on the MSDS and with local authorities.

7: Handling and Storage

Precautions: Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe gas/fumes/ vapor/spray. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, reducing agents, acids, alkalis, moisture.

Storage: Hygroscopic. Keep container tightly closed. Keep container in a cool, well-ventilated area. Do not store above 23°C (73.4°F).

8: Exposure Controls/Personal Protection

Engineering Controls: Provide exhaust ventilation or other engineering controls to keep the airborne concentrations of vapours below their respective threshold limit value. Ensure that eyewash stations and safety showers are proximal to the work-station location.

Acute Potential Health Effects:

Skin: May cause mild skin irritation. It may be absorbed through the skin and cause systemic effects like those of ingestion.

Eyes: May cause mild eye irritation with some immediate, transitory stinging, lacrimation, blepharospasm, and mild transient conjunctival hyperaemia. There is no residual discomfort or injury once it is washed away.

Inhalation: May cause respiratory tract irritation.

Ingestion: It may cause gastrointestinal tract irritation. It may affect behaviour/central nervous system(CNS depression, general anaesthetic, convulsions, seizures, somnolence, stupor, muscle contraction or spasticity, coma), brain (changes in surface EEG), metabolism, blood (intravascular haemolysis, white blood cells - decreased neutrophil function), respiration (respiratory stimulation, chronic pulmonary enema, cyanosis), cardiovascular system(hypotension, bradycardia, arrhythmias, cardiac arrest), endocrine system (hypoglycaemia), urinary system (kidneys), and liver.

Chronic Potential Health Effects: Skin: Prolonged or repeated skin contact may cause allergic contact dermatitis. Ingestion: Prolonged or repeated ingestion may cause hyperglycaemia and may affect behaviour/CNS (symptoms like that of acute ingestion). Inhalation: Prolonged or repeated inhalation may affect behaviour/CNS (with symptoms like ingestion), and spleen
